Geologic Aspects of Aggregates in Highway Construction, What Highway Engineers Often Overlook

Rocks are widely used as aggregate materials for construction purposes. The formal definition of an aggregate depicts the wide range of materials and uses: prominent among these are gravel and crushed stone used in concrete and asphalt, plus base courses that support these pavements. Rock strength and durability are important properties of concrete and bituminous aggregates. Strength is indicated by the Los Angeles Abrasion loss and durability by density, absorption and soundness tests. Soundness measurements include: sulfate soundness, freeze thaw and Micro Deval tests on unconfined aggregates. For concrete resistance, the beam freeze-thaw test is also employed. An important addition for carbonate aggregates is the acid insoluble residue test. Results of these tests are directly related to specific rock materials and a detailed petrographic evaluation provides valuable information. Various aggregate and concrete problems can be related to individual rock characteristics to underscore the close associations at work. These important relationships between specific rock materials and behavior of concrete and asphalt pavements commonly are not fully appreciated by material engineers who possess limited geologic training.

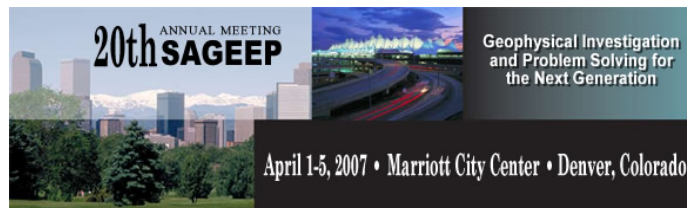
Of particular note are the following:

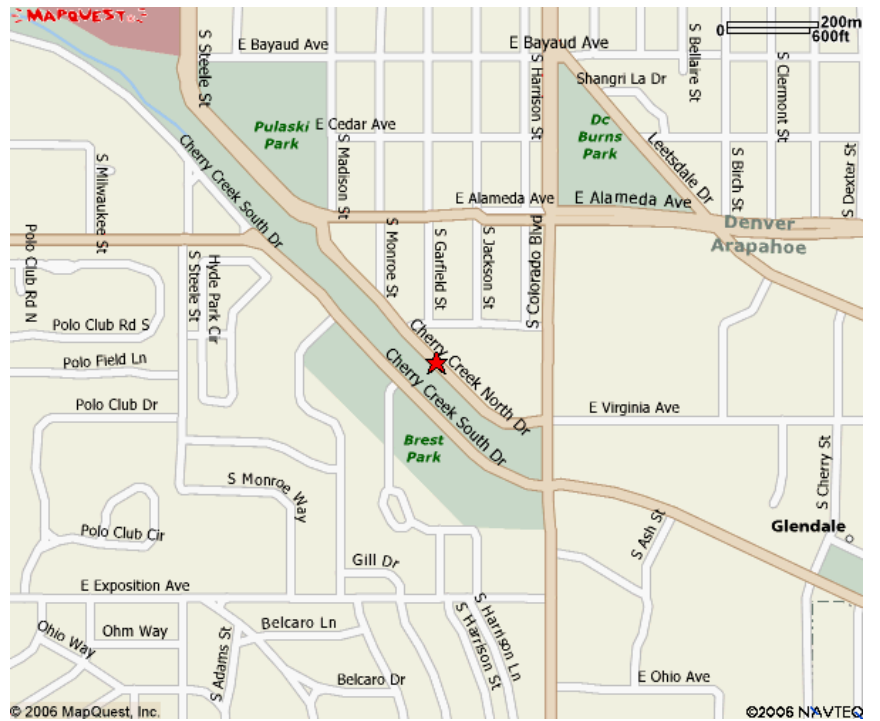
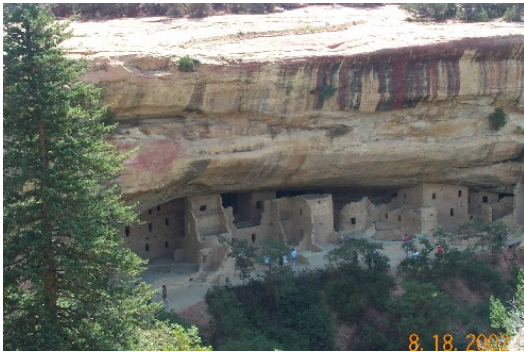
